**1<sup>ST</sup> ANNUAL OPEN TOURNAMENT**  
**TOURNAMENT RULES**

1. **Eligibility:** All members of the Greater Bloomington USBC are eligible to enter. Non members may enter by paying applicable dues – USBC \$10 and Greater Bloomington USBC \$7. Bowlers not yet 18 years of age must provide a parental consent form, in accordance with USBC Rule 13.
2. **Awards:** USBC Championship awards and trophies will be awarded to the handicap champions in each event. In case of ties for first place in any event, co-champions will be declared.
3. **Multiple participation:** Multiple participation will be allowed in team and doubles events, however not more than three bowlers on the same team may place more than once in the team prize list and the same doubles partners may not place more than once in the doubles prize list. Entrants in the singles event must also bowl the doubles event, with singles being bowled first. Multiple doubles will be scheduled as lanes are available. The first score bowled in team or doubles will count towards all events.
4. **Substitutions:** Substitutions will be allowed in accordance with USBC Rule 324b.
5. **Averages: USBC Rule 319a:** Averages submitted must be the highest sanctioned average for the 2008-2009 season (minimum of 21 games). If no average for the 2008-2009 season, a bowler may use their current average of at least 15 games as of February 1, 2010 (must have dated league standing sheet). A bowler may use a 2009 summer league average of at least 21 games if no winter average. USBC Rule 319a.2. (10 pin rule) does apply as of the start of the tournament. All members currently classified as PBA members are limited to two bowlers on any 5-person team and only one member in the doubles event. **Failure to use the proper average or make corrections within 48 hours after bowling the event shall disqualify the score if the submitted average is lower than the actual average or prize winnings will be based on the submitted average if higher.**
6. **Handicap:** Handicap will be based on 90% of the difference between the bowler's average and 230.
7. **Tardiness:** A team or individual that does not appear on the lanes when scheduled to bowl shall forfeit their entry, unless the tournament management finds that a sufficient reason is given for rescheduling. Under **NO** circumstances shall make-up frames be allowed. **Check in one hour before squad time.**
8. **Average Adjustment (Rerating): USBC Rule 319c:** The average of a bowler may be adjusted upward before participation in any event. If the bowler does not accept the assigned average, the entry fee shall be refunded. **USBC Rules 319d and 319e are waived.**
9. **Management: USBC Rule 303:** Tournament management has supervisory control of all technical parts of the operation of the tournament, including drafting the schedule and prize list. The decision of tournament management shall be final except where an appeal is made to USBC Headquarters in accordance with USBC Rule 329.
10. **Prizes: USBC Rule 308:** All prize fees collected in an event or division of an event will be returned 100% to the participants in that event or division of that event. Prizes are based on a minimum of 1 in 4 for each event. All prizes will be prorated according to entries. Prize payment will be within 30 days after the end of the tournament. All event entry is included in team, doubles and singles entry fees.
11. **Entries:** The starting date of the tournament is March 6, 2010. The ending date of the tournament is March 14, 2010. The closing date and time of all entries is 1 hour prior to the start of the last squad in any given event. Total entry fees must be paid no later than the time of bowling. USBC cards must be presented at time of check-in.
12. **Checks:** The Greater Bloomington USBC accepts checks and any check returned for any reason will be subject to a service fee of \$25.00.
